**CONSENT:** In submitting this form, I agree to the following:

- I agree to my child taking part in Hackney RFC junior section coaching and training activities and events.
- I agree to my child taking part in games or other events or activities organized by or entered into by Hackney RFC, including games against or organized by other rugby clubs.
- I confirm that, to the best of my knowledge, my child does not suffer from any medical condition other than those listed.
- I consent to my child travelling by any form of public transport or by minibus or by motor vehicle and wherever possible that will be under the supervision of an authorised official of Hackney RFC or another parent known to the Club who has agreed to be bound by the Club's safeguarding rules.
- Where my child (or the child in my care) is away from direct parental (or guardian) control or direction in the course of Hackney RFC activities or events and, in the course of any of the above activities or events, a qualified medical practitioner gives his or her opinion that my child (or the child in my care) should be given medical treatment (including inoculations, blood transfusions or surgery). I understand that an authorized official of Hackney RFC will seek at least twice to contact me on the telephone number(s) I have given but should they not be able to get hold of me, I authorize the Hackney RFC, and in particular any official or representative of the Hackney RFC present at the time, to consent to such medical treatment to my child (or the child in my care) as if such consent had been given personally by me.
- I consent to the taking of photographs and films of my child in the course of any of the above activities or events and consent to their publication in all forms of media including but not limited to newspapers, TV, Websites, or Hackney RFC displays or advertising material.
- I understand that as a developing club with a mixed age range Hackney RFC have to mix the age groups of its teams meaning that children will train with other children who are of a different age group. I understand that Hackney RFC will adhere to the regulations and guidance issued by the RFU in all matters relating to age grade rugby. I understand that I can speak to the head coach or the safeguarding officer to discuss my child's circumstances and any issues or concerns that I may have.
